1. Please briefly describe the project, including its significance, key goals, and principal activities.

The Caste Freedom Index (CFI) is a unique and universal framework for addressing inequalities and measuring discrimination based on caste or descent of nearly 300 million of the world's most marginalized and socially excluded population known as "Dalits" or "Oppressed people".

Its goal is to provide a new zeal for Dalits, advocacy groups, policy-makers, development actors and governments needing on-the-ground evidence and framework to address inequalities and injustice on local, national and international levels.

The CFI will be collectively developed as a new effort to measure legal, social, and development progress in reducing and eliminating caste-, work-, and descent-based discrimination and inequality on five thematic human rights factors.

The CFI dashboard is based on a framework matrix which will chart the objectively measured situation of Dalits as the interrelationship between six human rights dimensions and a set of socio-political domains such as law, politics and the economy.

2. Please list anticipated project outcomes and specific deliverables.

The CFI project can be broken down into four stages, each of which will contain a number of work packages. It is likely that funding will have to be sought for each stage, and potentially for specific work packages within stages. The stages proposed are:

- 1. Pilot development (stage 1 was already undertaken)
- 2. Interim roll-out within Nepal
- 3. Full roll-out within Nepal
- 4. International development

Work package 2 - Survey development

• Ensure understanding of key population characteristics

- o It will be necessary to have an overview of population numbers, social organisation, geographical and socio-economic distribution, caste, religious and linguistic breakdown of Dalit communities in Nepal, to guide development of the sampling and delivery strategy.
- Develop sampling and delivery strategy
- o The sampling and delivery strategy will depend to some extent on the availability of field resources and the views of local partner organisations.
- o At the pilot stage, it may be desirable to focus mainly on testing the ability of the survey to deliver in a range of geographical, social and linguistic settings.
- Develop and test questions
- o Questions will focus mainly on the two selected human rights dimensions, but the opportunity may be taken (within available resources) to cover high priority issues relating to certain other dimensions.
- o To ensure reliability (and credibility) a full question testing process will be required, including discussion of drafts with local partners, cultural and linguistic experts, cognitive testing and small-scale field testing.
- Deliver and report pilot survey

Work package 3 - Expert consensus development

- · Decide on consensus methodology
- o The chosen approach will have to be capable of implementation by correspondence.
- o It would be preferable for the approach to be capable of reaching a 'score' for each indicator as its outcome.
- Recruit expert panel members
- o To aid credibility, expert panel members will have to be widely recruited e.g. not all be Dalits or connected with ICDR.
- o Formal agreement should be reached with panel members on practical matters such as response times.
- Collect key documents for assessment
- o Documents may include (e.g.) legal texts, court records, political manifestos, written organisational policies.
- Conduct and report consensus exercise

Work package 4 - Existing sources discovery and assessment

- Identify potential sources of (a) published statistics, (b) available raw data relevant to the dimensions of interest
- Explore data sources for availability by key variables, especially caste, and for data quality and timeliness
- Construct candidate indicators and report on quality and sustainability o It may be worthwhile constructing close proxies for candidate indicators if these would be feasible and of sufficient relevance and quality.

Work package 5 - Synthesis and forward planning

- · Develop scaling and weighting approach for combining indicators
- o Scaling is likely to be approached on a technical basis, however weighting may require (e.g.) a preference exercise using an expert panel
- Make final decisions between experimental versions of indicators
- Construct final CFI matrix proof of concept for presentation
- Plan next stages in discussion with funders and local partners

The Stage that has been achieved so far is Stage 1. ICDR is planning to set up an expert meeting in March to discuss in further details our future developments.

Work package 1 - Scoping and planning

- Agree conceptual scope of the selected human rights dimensions
- Identify candidate indicators and map to CFI matrix
- o The candidate indicators could be generated from expert 'brainstorming', literature search, etc. A potentially large number could be generated for discussion.
- Make initial assessments of appropriateness and feasibility, select subset of indicators and assign to data collection approaches
- o An optimum number of indicators per matrix cell may be decided at a later date, but flexibility will be necessary at the experimental stage.
- o Any one proposed indicator might be assigned to more than one data collection method (e.g. both use of existing data and survey collection) if this would be useful at the experimental stage, with a subsequent decision being made on the basis of data quality, comparability with other indicators, etc.
